### 1. Opening of the Meeting

Dr. John Kelley called the meeting to order.

## 7. Report of TC20/SC13 Liaison Activities

The TC20/SC13 Secretariat received correspondence from Mr. Hans Hofman of TC46/SC11 concerning a liaison relationship. TC46/SC11 develops standards for the management of records and archives. The correspondence was forwarded to Mr. Don Sawyer, chair of the CCSDS Data Archives Working Group. Mr. Sawyer stated that a liaison consisting of document and status report exchange will be enacted between the two groups. The Secretariat will also add TC46/SC11 to the TC20/SC13 mailing list. (Resolution and Action Item SC13-0510-1.)

It was reported that Mr. Mario Merri, chair of the CCSDS Spacecraft Monitor and Control Working Group, is working with TC20/SC14 WG3 – Operations and Ground Support.



### 8. New Business – Status of TC99

Dr. Kelley reported that TC20 did not approve the proposed creation of a new Technical Committee for Space Systems. Both TC20/SC13 and SC14 produce a large portion of the standards within TC20 and the chair did not want the subcommittees to transition to a new TC. Further discussions concerning the status of the planned TC in Space Systems will be held at the next TC20/SC14 meeting in Colorado Springs, USA, 15-20 May 2006. Ultimately, the ISO Technical Management Board (TMB) will make the final decision on the formation of a new TC for Space Systems.

### 9. Future Meetings

The following tentative schedule was agreed for the 2006 Fall/2007 Winter CCSDS meeting:

## 10. Review and Approval of Resolutions and Action Items

Mr. Adrian Hooke recommended that instead of issuing resolutions for approvals of CCSDS documents at the TC20/SC13 meetings, they should have their submission approved by means of the regular, pre-meeting CCSDS Management Council e-polling process. The Secretariat was issued an action item to develop a process that submits CCSDS documents to ISO after their e-poll approval (Resolution and Action Item SC13-0510-2). The following CCSDS documents were approved for forwarding to ISO Central for DIS review:

- CCSDS 122.0-B-1, *Image Data Compression* (new)
- CCSDS 135.0-B-2, Space Link Identifiers (update of PRF 22647)
- CCSDS 910.4-B-2, Cross Support Reference Model--Part 1: Space Link Extension Services (update of ISO 15396:1998)

The draft Resolutions and Action Items were reviewed (Attachments 12 and 13).
